RDA Charter – Regional Investment Framework

Our work with Coffs Harbour over the past financial year has been focused on understanding the unique needs of the region and working on opportunities.

- Manufacturing capability support
- Supporting the Gloucester community champions to navigate the complex transition of mining economy to a still prosperous future
- Circular economy and waste

- Connectivity

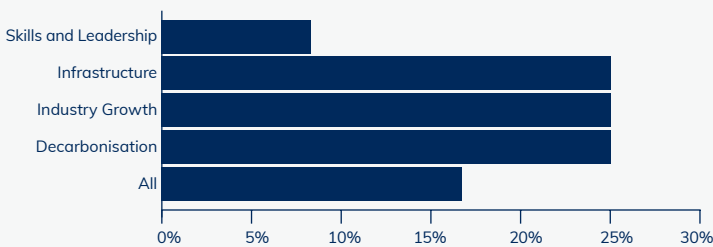
RDAMNC have collected data on our activity delivered over 2023-2024. This data relates to meetings, project support, forums held in the area, investment support and other activities.

Table 1: Midcoast engagement by priority area



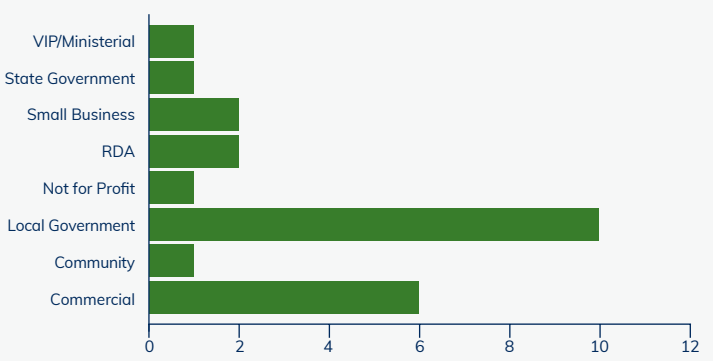
Our efforts in Midcoast LGA have been focused on:

- Decarbonisation – working to identify opportunities to participate in the energy transition
- Industry Growth – improving structural barriers for firms such as energy and infrastructure
- Infrastructure – understanding the Council and industry’s needs and supporting efforts to secure funding from available grant pools.

The following statistics reflect engagements encompassing all six LGAs on the Mid North Coast rather than individual LGA engagements.

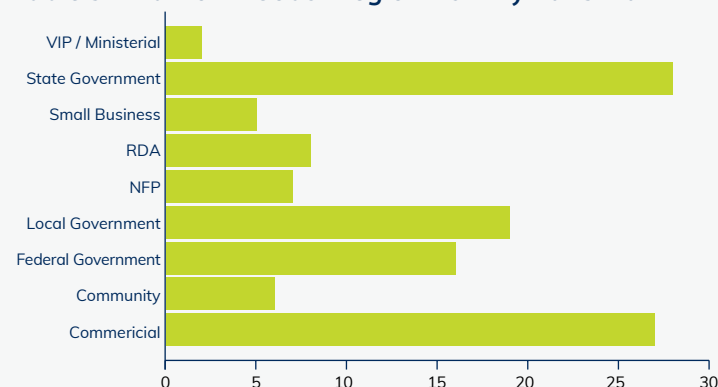
Engagements by Sector

Our total activity nationally, state wide, MNC and Norfolk Island are 515 for the financial year 2023-2024. Efforts centred purely on the Mid North Coast total 118 engagements. These engagements range from multi-stakeholder regional forums through to Teams meetings.

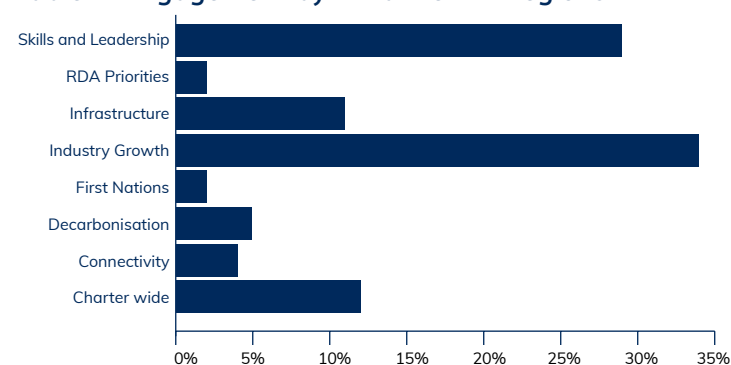
1. **MNC Labour Participation Study** with the Regional Australia Institute

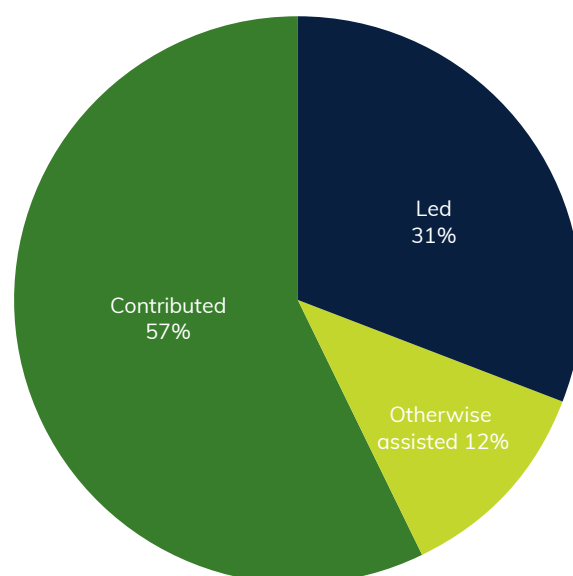
